#### GIPHCC Bylaw Revisions 2/9/11

4.07 Waiver of Notices

Notice of the time, place, and purposes of any meeting of the board of directors or of the executive committee may be waived by telegram, radiogram, cablegram, **email**, or other writing either before or after such meeting is held, or by attendance at the meeting.

7.03 Manner of Election and Term

Directors shall be elected at the Association's annual meeting, or special meeting duly called, by a vote of the members present and eligible to vote. Two directors shall be elected each year to serve for a term of two (2) years or until their successors have been elected and assume office. No member of the board of directors who has served five (5) successive terms shall be eligible for re-election until at least one (1) year shall have elapsed. If no successor is apparent, Board may extend member's service for one (1) term.

7.08 Quorum of the Board


At any meeting of the board of directors, no fewer than six (6) members of the board shall constitute a quorum for the transaction of the business of the Association and any such business thus transacted shall be valid, providing it is affirmatively passed by a majority of those present. A conference call may be made to absent members in order to obtain a quorum for necessary votes.

7.10 Voting by Mail

Action may be taken by a mail ballor, electronic ballot or by conference call ballot of the members of the board of directors, in which at least a majority of such directors, in writing or electronic or voice vote indicate themselves in agreement, shall constitute a valid action of the board if reported at the next meeting of the board.
